Cooling-off period: Students are able to change their mind and cancel their intended training. A cooling off period of 7 business days applies from the date they complete and sign their enrolment documentation.

1) Students who meet government funded training criteria. These students are only required to pay a student tuition fee and material fee (where required), and the government provides significant course subsidisation. The government will subsidise up to the 'Maximum Govt Subsidised Hrs' in the chosen course. 2) Students who do not meet the government funding eligibility requirements are required to pay all course costs and material fees required for their chosen field of study. 3) The Maximum Govt Subsidised Hrs are NOT the total hours to deliver the course. The student tuition fees are indicative only and subject to change given individual circumstances at enrolment. Additional fees may apply such as student services and amenity fees. This Training is delivered with Victorian and Commonwealth Government Funding. People with disabilities are encouraged to apply. 4) RPL (Recognition of Prior Learning)

Rate 1: Delivering the subject in a regional location. Skill First identify a regional location by the postcode of the 'training organisation delivery location', except for online training where we use the student's residential postcode. [online training means the predominant delivery mode is 'external' as defined by the Victorian VET student statistical collection guidelines.]

Rate 2A: Delivering the subject in a metropolitan Melbourne location and the delivery mode is classroom-based. [classroom-based means the predominant delivery mode for the subject is 'internal', as defined by the Victorian VET student statistical collection guidelines.] Rate 2B: Delivering the subject in a metropolitan Melbourne location and the delivery mode is online/distance or workplace-based. [online/distance or workplace-based means the predominant delivery mode is 'external' or 'workplace-based', as defined by the Victorian VET student statistical collection guidelines.]
